ROAD TRANSPORT ACT 1987**MOTOR VEHICLES (SAFETY SEAT-BELTS)
(AMENDMENT) RULES 2008**

IN exercise of the powers conferred by section 66 of the Road Transport Act 1987 [Act 333], the Minister makes the following rules:

Citation

1. These rules may be cited as the **Motor Vehicles (Safety Seat-Belts) (Amendment) Rules 2008**.

Amendment of rule 2

2. The Motor Vehicles (Safety Seat-Belts) Rules 1978 [P.U. (A) 378/1978], which is referred to as the “principal Rules” in these Rules, are amended by inserting after rule 2, the following rule:

“Rear Seat of a motor vehicle to be fitted with safety seat-belt. 2A. (1) Subject to rule 6, every rear seat of a motor vehicle shall be fitted with a safety seat-belt with three built-in anchorage points located in the best position for such fitting.

(2) Paragraph (1) shall apply to a motor vehicle registered on or after 1 January 1995.”.

Amendment of rule 3

3. The principal Rules are amended in subrule 3(2)—

(a) by inserting after for the words “paragraph (1) of rule 2” the words “and paragraph 1 of rule 2A”;

(b) by substituting for the word “applies” the words “and rule 2A apply”;
and

(c) by deleting the words “for the middle seat of a front bench seat or for any other front seat” and the words “for such seat”.

New rule 4A

4. The principal Rules are amended by inserting after rule 4 the following rule:

“Every person in rear seat of motor vehicle to wear safety seat-belts. 4A. Subject to rule 7, every person in the rear seat of a motor vehicle to which rule 2A applies shall wear a safety seat-belt in the manner required by its nature and construction from 1 January 2009.”.

Amendment of rule 6

5. The principal Rules are amended in rule 6—

(a) by substituting for paragraph (a) the following paragraph:

“(a) which is a motor vehicle designed and constructed for carriage of goods having maximum permissible laden weight exceeding three thousand five hundred kg;”;

(b) by substituting for paragraph (c) the following paragraph:

“(c) which is a motor vehicle designed and constructed for carriage of passengers with more than eight seats exclusive of the driver’s seat.”.

Amendment of rule 7

6. Rule 7 is amended by inserting after the words “Rule 4” the words “and rule 4A”.

Amendment of Schedule

7. The Schedule to the principal Rules is amended by inserting after item 8 the following item:

“9. MS 1175 Specification for Seat Belts for Motor Vehicles”.
