1. SCOPE

This standard is concerned with the basic requirements that must be met in the lump sugar.

3. **DEFINETIONS**

3.1 **Lump sugar :**

Is a big crystals of sparkling white sugar that produced from cooling over saturated sugar solution and high-purity crystals. Some healthy permitted food colors, flavorings and orders may be added.

4. REQUIREMENTS

- 4.1 The product shall be free from impurities.
- 4.2 The product shall be crystalline (Diamond Figure).
- 4.3 The product shall be sparkling white or sparkling color according to the added color.
- 4.4 Sucrose content shall not be less than 99.9%.

- 4.5 Humidity shall not be exceed than 0.05%.
- 4.6 Ash content shall not be exceed than 0.02%.
- 4.7 Preservatives are permitted to be added according to the Gulf standard mentioned in item (2.8).
- 4.8 Contaminating metallic elements shall not be more than the following:

- Arsenic 1 PPM

- Lead 0.05 PPM

- Copper 2 PPM

- 4.9 The product shall be free from pathogenic microorganisms.
- 4.10 The limits of pesticides residue shall not exceed the limits given in Gulf standards mentioned in Items (2.7),(2.8).
- 4.11 The product shall be processed according to the conditions given in the Gulf standard mentioned in Item (2.3).
- 4.12 The limits of radionativity shall not exceed the limits given in Gulf standard mentioned in Item (2.12).

5- SAMPLING:

Samples shall be carried out according to GSO standard mentioned in Item (2. 5).

6- METHOD OF TESTS:

6.1 Tests shall be carried out according to GSO standards which are mentioned in (2.2), (2.4).

7- PACKAGING, TRANSPORTATION AND STORAGE:

7.1 **Packaging:**

- 7.1.1 Without prejudice to provisions of GSO Standard mentioned in Items (2.10), (2.11).
- 7.1.2 The product shall be packed in package impermeable to moisture, and shall maintain the properties of the packaged material and protect it from gaining undesirable odors, flavors and taste.

7.2 **Transportation:**

Packages shall be transported in such a way as to protect the contents of product from any change, damage, deterioration and contamination.

7.3 **Storage**:

7.3.1 Packages shall be stored in stores complied with the requirement in GSO Standard mentioned in item 2.9.

7.3.2 The product shall be stored in a clean dry place, good ventilation and away from direct sunlight.

7.3.3 The product shall be stored in a place away from the sources of pollution with pesticides and chemicals, insects and rodents

8- LABELING:

Without prejudice to provisions of GSO Standard mentioned in Item (2.1) and Item (2.6) and shall be declared on the label of the product.

- 8.1 Name, address and trademark of the product, if any
- Name and address of the packer and trademark.
- 8.3 Product name.
- 8.4 Date of production expiry date or validity period.
