*The residue definition for Oxfendazole, Febantel and Fenbendazole is sum of Oxfenbendazole sulfone **【Methyl [5-(Phenylsulfonyl)-1*H*-benzimidazol-2-yl]carbamate】**, Oxfendazole and Fenbendazole, expressed as Oxfenbendazole sulfone.

The current residue definition is sum of Oxfenbendazole sulfone, Oxfendazole, Febantel and Fenbendazole, expressed as Oxfenbendazole sulfone.

* The uniform limit 0.01 ppm will be applied to commodities not listed above.

* Diagonal line means the food category to which MRL applies is not set.

*Regarding the MRLs in food categories, "Turkey, muscle" and "Other poultry except, Turkey muscle" will be deleted, whereas new MRL will be established in food categorized as "Other poultry, muscle".

*Regarding the MRLs in food categories "Turkey, liver" and "Other poultry except, Turkey liver" will be deleted, whereas new MRL will be established in food categorized as "Other poultry, liver".

1. "Other terrestrial mammals" refers to all terrestrial mammals, except cattle and pig.

2. "Edible offal" refers to all edible parts, except muscle, fat, liver and kidney.

3. "Other poultry" refers to all poultry, except chicken.
