This Kenya Standard specifies the requirements and test methods for alcoholic mixed beverages.

3 Terms and definitions

For the purposes of this document, the following definitions apply.

alcoholic mixed beverage

alcoholic beverages derived from blending of potable undenatured spirits, beers, wines as base with natural/nature identical/artificial additives permitted under GSFA and preserved chemically, carbonation or heat treatment.

4 Requirements

4.1 Ingredients

4.1.1 Ethyl alcohol

Ethyl alcohol content in this product shall be 3 % minimum (5.25 $^{\circ}$ proof) at 20 $^{\circ}$ /20 $^{\circ}$ C when determined according to the method prescribed in KS EAS 104. The tolerance limits for ethyl alcohol content shall be \pm 1.0 % of the declared strength.

4.1.2 Freedom from harmful ingredients

The product shall be free from any ingredients injurious to health and shall be free from sediments or suspended matters except for the components incorporated in colloidal suspension and roughage from fruit/juice.

4.1.3 Colours and additives

The product may contain natural/natural identical/ synthetic permitted food colours and additives as defined by GSFA

4.1.4 Taste and aroma

The product shall possess the characteristics taste and aroma associated with respective base material to enhance the characteristics flavour of the product, natural/nature identical/artificial flavours permitted may be used.

4.1.5 preservation

The product may be carbonated with carbon dioxide (see Table 1). Other preservation methods may include pasteurization, chemical preservatives, nitrogen gas or other suitable methods as prescribed in Codex alimentarius.

4.1.6 Water

The water used in the manufacture of the product shall be potable complying with KS EAS 12.

4.1.7 Edible salt

Edible salt if used in the manufacture of the product shall comply with KS EAS 35

4.2 Specific requirements

The product shall comply with the specific requirements given in Table 1 when tested in accordance with the test methods prescribed therein.

5 Heavy metal contaminants

The product shall comply with the heavy metal limits given in Table 2 when tested in accordance with the test methods prescribed therein.

6 Hygiene

The products shall be manufactured in approved and licensed premises built and maintained under hygienic conditions stipulated in KS 1499 and KS EAS 39.

7 Fill of container

The fill of container shall be in accordance with the Weights and Measures Act, Cap. 513 of the Laws of Kenya.

8 Packaging

The product shall be packaged in food grade material that does not affect the quality and safety of the product.

9 Labelling

In addition to the requirements of KS EAS 38, the package shall be legibly and indelibly marked with the following information: $\frac{1}{2}$

- a) name of product;
- b) net contents;
- c) name and physical address of manufacturer or packer, distributor, importer or exporter;
- d) date of manufacture;
- e) expiry date;
- f) storage instructions;
- g) country of origin;
- h) ethyl alcohol content; and
- i) batch or lot number.
