

# **The Draft of Amendment of Regulation of Imported Beef and Beef Products from the United States and Canada.**

(TRANSLATION)

(In the case of any divergence in the translation, the Chinese text shall prevail.)

1. Requirements for beef and beef products
  - i. Only beef derived from cattle born and raised in the United States or Canada; or from cattle born in a country deemed eligible by Taiwan to export beef; or from cattle raised in the United States or Canada for at least 100 days prior to slaughter in the United States or Canada will be considered eligible for export to Taiwan.
  - ii. The beef shall be from meat establishments approved by the veterinary authority of exporting countries, have passed ante-mortem and post-mortem inspection under the supervision of a veterinarian, and were not subjected to a stunning process, prior to slaughter, with a device injecting compressed air or gas into the cranial cavity, or to a pithing process.
  - iii. The beef shall not contain specified risk materials (SRMs), any mechanically recovered meat (MRM), mechanically separated meat (MSM), or advanced meat recovery (AMR) derived from cattle skull and vertebral column from cattle aged 30 months or older at the time of slaughter.
  - iv. Shipments of beef shall be accompanied by certificates issued by

the exporting countries.

- a. The beef or beef products shall be from meat establishments registered with U.S. Department of Agriculture, approved by Taiwan's authorities, and with statement of "The beef or beef products were derived from cattle that were slaughtered in meat establishments certified by USDA as eligible to export beef or beef products to Taiwan and that passed ante-mortem and post-mortem inspection conducted by USDA personnel under the supervision of the resident designated veterinary representative." or equivalent statements.
  - b. The beef or beef products from meat establishments shall be registered with Canadian Food Inspection Agency, approved by Taiwan's authorities, and with statement of "the beef and beef products are derived from cattle of all ages" and "the beef and beef products are derived from cattle that were slaughtered in establishments certified by the CFIA as eligible to export beef to Taiwan and that passed ante-mortem and post-mortem inspection under the supervision of a CFIA veterinarian".
2. Skulls, brains, eyes, spinal marrow, ground beef, viscera and other related products shall not be imported, including 36 HS code items listed in Table.
  3. If the imported beef or beef products are found non-compliance with the *Act Governing Food Safety and Sanitation*, the lot of beef or beef products shall be handled according to relevant legislation, regulations, administrative rules, procedures and other measures.
